I, Membathisi Mphumzi Shepherd Mdladlana, Minister of Labour, in terms of section 56 (1) of the Basic Conditions of Employment Act, No 75 of 1997, hereby amend Sectoral Determination 11: Taxi Sector, South Africa, published under Government Gazette R.409 of 28 April 2005 in accordance with the schedule hereto and fix 1 July 2008 as the date on which this amendment shall become binding.

PART B: MINIMUM WAGES

Replace clause 2(1) as reflected in Government Notice R.409 of 28 April 2005 with the following:

2 MINIMUM WAGES

- (1) With effect from 1st July 2008 an employer must pay an employee, at least the minimum wage prescribed in this clause.

Replace Table 1 in clause 2 (2) as reflected in Government Notice R.409 of 28 April 2005 with the following table:

Substitute clause 9 (1) (a) as reflected in the Government Notice R.409 of 28 April 2005 with the following:

9 BOARDING ALLOWANCES

- (1) If an employer requires an employee to sleep over at a place other than where the employee resides, the employer must either-
- (a) pay the employee the amount as reflected in table 2 below per night; or
