### Opening Remarks by Mr Thobile Lamati

### Good morning, and Thank you, Mr Ndebele.

Delegates and representatives of BRICS Member Countries and Guest Countries.

I also want to recognise representatives of Social Partners, the International Labour Organization, International Social Security, the African Union, the Pan African Productivity Association (PAPA), the African Regional Labour Administration Centre (ARLAC) as well as the development financial institutions.

Ladies and gentlemen, as the Chairperson of the BRICS Employment Working Group (BEWG), I am deeply honoured to welcome you all to the Fourth and Final BEWG meeting here in the beautiful city of Durban. The meeting will take place today and tomorrow. We are gathered here to prepare for the Meeting of Ministers of Labour and Employment, which will take place on Thursday and

Friday. We need to prepare and finalise the discussions within the set timeframe. I, therefore, beg for your indulgence and cooperation as we move forward.

This journey began several months ago, starting in Misty Hills, Johannesburg, in February, and took us to Port Alfred in May, followed by a meeting in Geneva in June on the sidelines of the International Labour Conference. This amazing trip has taken us to a final stop, the Fourth BEWG.

I want to express my heartfelt gratitude to all of you for your unwavering dedication and determination in seeing this journey through. We anticipate the forthcoming meeting with our Ministers will mark the conclusion of this significant effort before we hand over the reigns to the Russian Federation.

A special acknowledgement is due to the distinguished representatives of the BRICS Partners and our esteemed guests who have travelled from afar to be with us today. We particularly note the presence of the Cuban and Kenyan delegations that are joining our collective for the first time. Everyone's presence signifies our commitment and diligence to addressing the challenges and opportunities in the World of Work. We are deeply appreciative of your support.

I must also recognise and extend a warm welcome to the political leaders who grace us with their presence here today. Your support is instrumental in achieving our goals.

Furthermore, we extend our warmest welcome to the representatives of workers and employers. Your perspectives and input are invaluable as we strive to ensure decent work for all. We are also honoured to have distinguished organizations and international partners with us today, who have been vital to our efforts during all our meetings.

Our meeting and Presidency are guided by a theme that aligns with the aspirations of the global community: "Ensuring Decent Work, Dignity, and Respect for All". In pursuit of this noble goal, we have identified and deliberated on four overarching priorities that form the foundation of our discussions.

Firstly, we have focused on respecting, promoting and realising fundamental principles and rights at work, with the aim of creating an enabling environment for freedom of association, collective bargaining and enhancing tripartism.

Secondly, we have addressed the crucial issue of access to social protection, recognizing it as a fundamental human right, and committing to integrating universal access to social protection within our national frameworks.

Thirdly, we have discussed strategies to bridge the skills gap for informally employed workers through investments in skills development systeMs

Lastly, we have explored ways to promote sustainable enterprises, and innovation as well as enhancing productivity.

From these discussions, the South African Presidency has put forth several key proposals. We have suggested the establishment of the BRICS Productivity Ecosystem for Decent Work Platform. This initiative aims to foster economic growth, sustainable enterprises, and productive employment creation through collaboration, knowledge-sharing, and monitoring and evaluation.

We are pleased that the BRICS Partners have welcomed this idea and allowed us to formalize it through the Leaders' Summit. The BRICS Productivity Ecosystem for Decent Work is on today's agenda, and we look forward to the host country and the ILO leading this discussion.

Additionally, we have proposed strengthening social dialogue and cooperation not only among BRICS member states but also with social partners. We value the contributions of our social partners in addressing the challenges facing the world of work. Our aim is to formally recognise their meetings as part of the BRICS Labour and Employment Ministers' Meeting and to elevate this relationship on various platforms while retaining their independent streaMs The BRICS Trade Union Forum is taking place in one of the venues nearby and at least 50 people are participating in the workers' meeting.

Linked to this proposal is the idea of leveraging our collective strength to enhance our global influence. This is particularly relevant given the inclusion of new members in our coalition. Following the BRICS Leaders' Summit last August, we duly note the admission of Argentina, Egypt, Ethiopia, Iran, Saudi Arabia and the United Arab Emirates. Therefore, our proposal calls for intensified engagement within international organizations and platforms to shape global labour market policies and agendas.

The outcomes of our BEWG meetings will include a Ministerial declaration, a Joint Political Statement, the adoption of the report from the BRICS Research Network, and preliminary ideas on how to proceed with the BRICS Productivity Ecosystem for Decent Work, in alignment with the instructions from our leaders.

Once again, I extend my warmest welcome to all participants, and I am confident that our collective efforts will pave the way for a brighter future in the world of work.

Thank you for your attention, and I look forward to fruitful deliberations over the next two days.
