(See Employment Services Act no.4 of 2014 sections 13, 14, 50 and Schedules 2 and 3, and Skills Development Act 1997 section 24 and its Regulation 608 of 2000.). Registration is valid for two (2) years.
2. The intention of this list is for any stakeholder to verify if an employment agency is indeed registered, and registered to offer the employment services they do, and to give work seekers and (current and potential) clients of employment agencies, access to the contact details of registered employment agencies. Permission to use information on this list for marketing or any other purpose must be obtained directly from the relevant employment agency.
